(1) Fixed Fuel Tax:

(A) Effective January 1, 2016, the fixed portion increases 1½¢ each January 1, thru 2019. ½¢ each to NDOR, cities and counties.

(B) July 1, 2009, the 10.3¢ fixed tax was distributed 7.5¢ to the Department of Roads and 2.8¢ to the cities and counties, 50% each.

(C) October 1985 until June 30, 2009 the fixed portion was 12.5¢ to the Department of Roads and 2¢ to the cities and counties, 50% each.

(2) The variable tax is distributed 100% to the Department of Roads.

(3) The wholesale tax is distributed 66% to the Department of Roads and 17% each to the cities and counties.
