(1) Fixed Fuel Tax:

- (A) Effective January 1, 2016, the fixed portion increased 1½¢ each January 1, thru 2019. This cumulative 6¢ increase included 2¢ each to Nebraska DOT, cities and counties.
- (B) July 1, 2009, the 10.3ϕ fixed tax was distributed 7.5ϕ to the Nebraska DOT and 2.8ϕ to the cities and counties, 50% each.
- (C) October 1985 until June 30, 2009 the fixed portion was 12.5ϕ to the Nebraska DOT and 2ϕ to the cities and counties, 50% each.
- (2) The variable tax is distributed 100% to the Nebraska DOT.
- (3) The wholesale tax is distributed 66% to the Nebraska DOT and 17% each to the cities and counties.
