All bridges in Nebraska are safety inspected every two years by certified bridge inspectors.

Good Bridges – when the major bridge components are all in good condition or better.

Poor Bridges – when one or more of the major bridge components are in poor condition or worse.

Fair Bridges – all other bridges

Major Bridge Components – Bridge Deck, Superstructure, Substructure

Low Load Rating but not Poor condition may warrant corrective action to replace or strengthen a bridge. Thresholds: ADT 0-500 and Inventory Load Rating < 12T, or ADT 501-5000 and Inventory Load Rating < 14T, or ADT >5000 and Inventory Load Rating < 18T.
