NOTICE OF HIGHWAY IMPROVEMENT PROJECT

(EB) I-80 Bridges in Omaha

Project No.: NH-80-9(81) Control No.: 22594

Identified as **Eastbound (EB) I-80 Bridges in Omaha**, the proposed project would repair and resurface four bridges along Interstate 80 (I-80) located in the City of Omaha in Douglas County. These four bridges include:

- S080 45103R (**EB I-80 over 50th Street**) between mile marker (MM) 450.96 and MM 451.10
- S080 45180R (**EB I-80 over 42nd Street**) between MM 451.73 and MM 451.87
- S080 45252 (**EB I-80 over Union Pacific at 34th Street**) between MM 452.44 and MM 452.60
- S080 45283R (**EB I-80 to northbound I-480 on-ramp**) between MM 452.76 and MM 452.90

Proposed improvements would consist of replacing approaches, expansion joint repairs,

deck repairs, resurfacing, and removing and replacing guardrail as necessary. Additional improvements would include grading beyond the hinge point.

The purpose of the proposed project is to preserve the transportation asset, improve the reliability of the transportation system, enhance safety and perpetuate the mobility of the traveling public. The need for the proposed project is based on the condition of the existing roadway and bridges.

This project would not require the acquisition of additional property rights. No wetland impacts are anticipated.

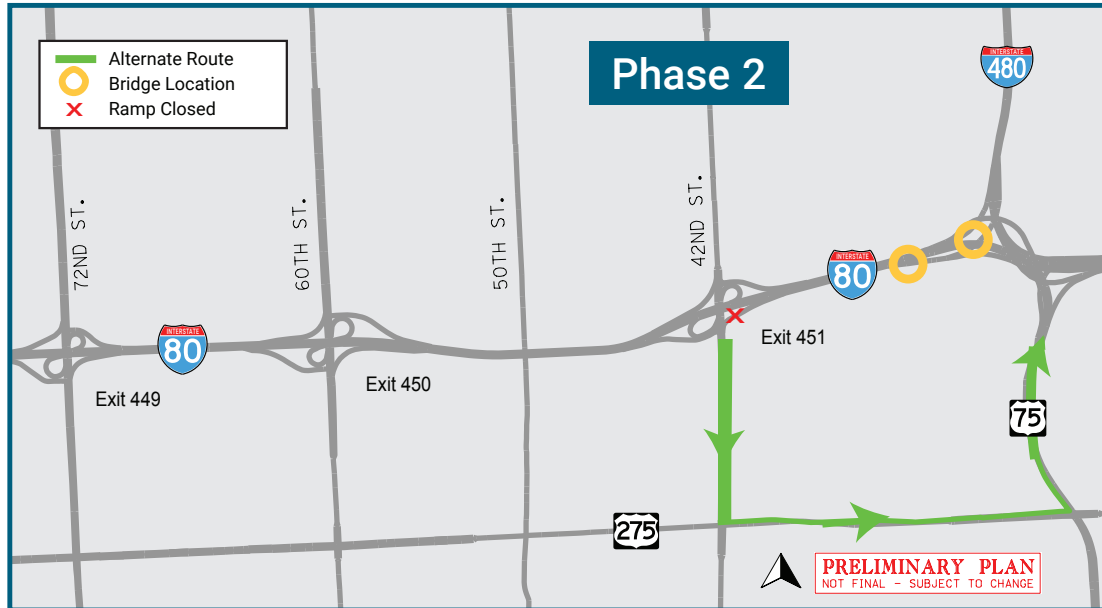
Construction is tentatively scheduled to begin in spring 2020 with completion in fall 2020.

The proposed project would be constructed primarily under traffic with lane closures controlled with approved temporary traffic control devices and practices. However, **the proposed project would require ramp and loop closures while work is performed.** Suggested alternate routes would utilize US Highway 275 (US-275) and US Highway 75 (US-75). **No ramp, loop or I-80 lane closures would occur during the College World Series or US Olympic Swim Trials.**

NDOT has worked to develop this project to minimize inconvenience and hardships. We are dedicated to improving Nebraska's highway system and with your help we can achieve this goal.
