NOTICE OF HIGHWAY IMPROVEMENT PROJECT

Seward West

STP-34-6(142); C.N. 13299

Identified as **Seward West**, the proposed project would improve approximately 13.57 miles of U.S. Highway 34 (US-34), located in Seward County.

The proposed project would begin at about MM 285.70 on US-34, at the York/Seward County line, and extend east to about MM 299.28, just west of the junction of US-34 and Nebraska Highway 15 (N-15). Construction may begin and/or end approximately 500 feet ahead of or beyond the actual project limits to accommodate transitioning the pavement.

The purpose of this proposed project is to preserve the US-34 transportation asset, improve the reliability of the transportation system, and perpetuate the mobility of the traveling public. The need for this proposed project is based on the current condition of the roadway.

Proposed improvements on this project would include milling and resurfacing the existing US-34 roadway and shoulders with asphalt. Additional work would include guardrail and culvert replacements.

The proposed project would require the acquisition of additional property rights which could include new right-of-way (ROW), control of access (CA), permanent easements (PE), and/or temporary easements (TE). If your property is impacted by this project, you will be contacted by a representative once the design footprint has been established. Access to adjacent properties would be maintained during construction but may be limited at times due to traffic phasing requirements.

Wetland impacts are anticipated and would be mitigated as necessary.

Construction could begin as early as summer 2024 and could be completed by fall/winter of 2025.

The proposed project would be constructed under traffic with lane closures controlled with approved temporary traffic control; however a temporary closure of County Road 476 (MM 285.71) at the intersection with US-34 would be required due to culvert work. A suggested alternate route would be provided utilizing Bluff Road, County Road 462, and Alvo Road.

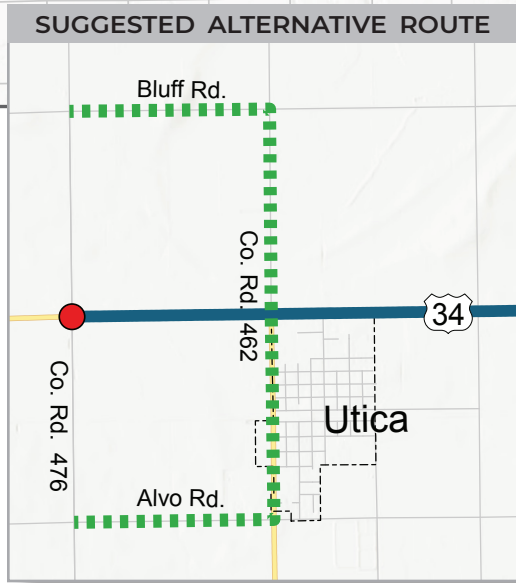
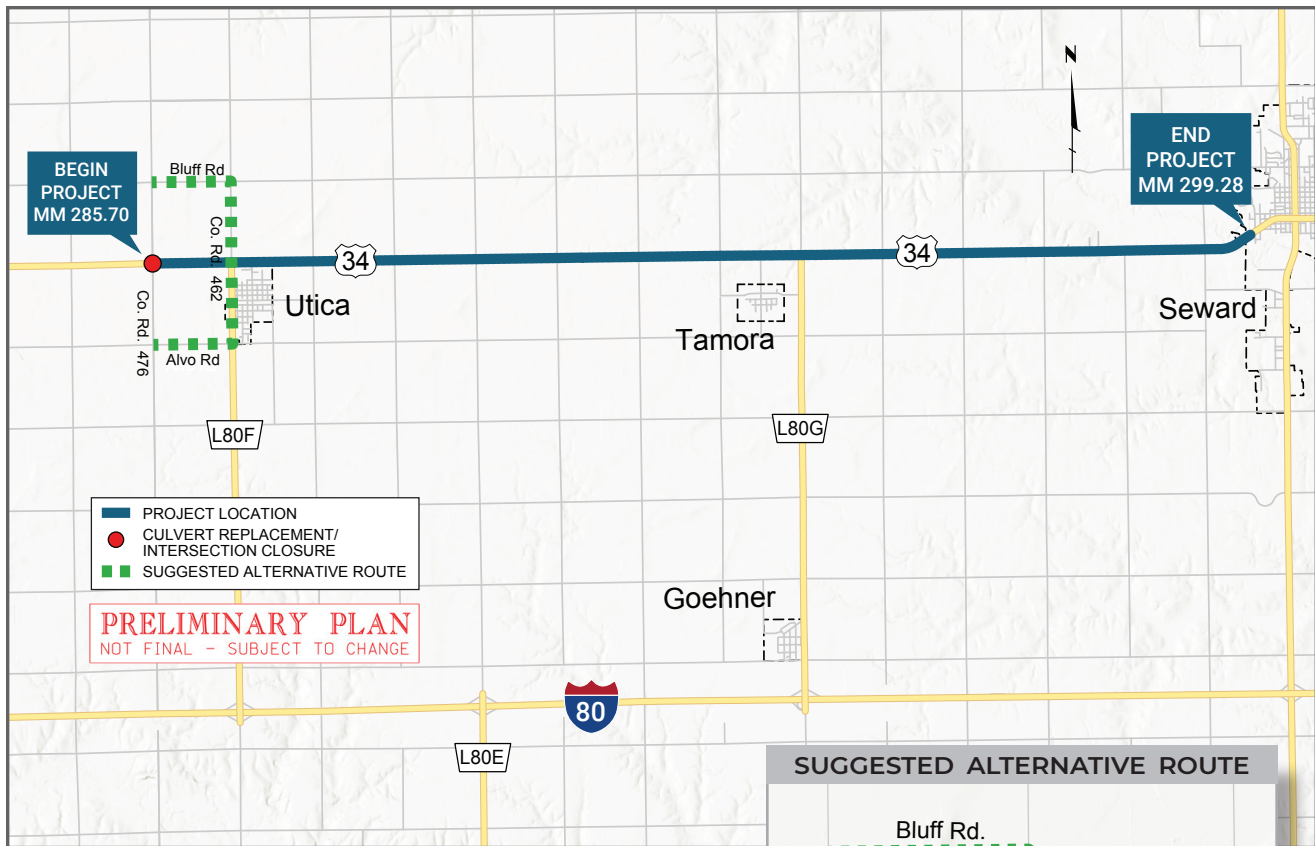
